ERA-Net CRUE

Based on a funding initiative entitled "ERA-NET" which is part of the Sixth EU Framework Programme, the ERA-Net CRUE project will introduce structure within the area of European research on flood risk management (FRM). CRUE is the acronym for *Coordination de la Recherche sur la gestion des inondations financée dans l'Union Européenne* (Coordination of the research financed in the European Union on flood management).

Currently ERA-Net CRUE consists of partners from the following European countries: Austria, Belgium, England, Finland, France, Germany, Hungary, Ireland, Italy, the Netherlands, Poland, Scotland and Spain.


FRM is a critical component of public safety and quality of life. In the past, EU member states and associated states have mainly promoted their own national flood research without comprehensive co-ordination between their programmes, entailing the risk of redundancies and of neglecting potential synergies. The vision for the ERA-Net CRUE action on flooding is to support and develop an extensive co-ordination and integration of regional, national, and European research programmes, projects and policies in the FRM field.

As a supplementary directive to the Water Framework Directive – 2000/60/EC, the European Union has adopted in 2007 the Floods Directive – 2007/60/EC which requires a preliminary assessment of flood risk, followed by the establishment of hazard and risk maps and FRM plans. The management plans will be developed for potentially endangered river basins, coastal areas and other flood-prone areas in the EU Member States by 2015. The implementation of the Floods Directive will require a broad basis of knowledge and tools and the development of improved management and governance strategies.

ERA-Net CRUE aims to contribute to this research by its 2nd Research Funding Initiative, launched in June 2008 by twelve of the partner countries, with the objective to establish trans-national collaborative research projects on Flood Resilient Communities – Managing the Consequences of Flooding, focussing on two thematic areas considered key elements of future FRM:

- 1) Improvement of risk awareness and increasing public participation; and
- 2) Flood event management.
