Presentation

Ecomondo Fair, with its 9th edition, confirms its role as the leading event that best brings together the environment and the market. By in-depth coverage of the numerous issues linked with the concept of "environmental sustainability", Ecomondo covers the complete waste cln the framework of the ECOMONDO Rimini Fair, on **28th October 2005**, the Innovation Relay Centre CIRCE and the Innovation Relay Centre IRENE will organise the **Trasnational Technology Transfer day in the field of "Air pollution"**.

In accordance with the European Union policy and the Kyoto Protocol, which aim at developing and implementing appropriate instruments for control and improvement of the quality of the air, the purpose of the event is to match technology profiles (offers and requests) concerning the most advanced systems and devices for monitoring and analysing atmospheric pollution. During the event, companies, universities, research centres and public administrations operating in improving the air quality will have the opportunity to exchange information and present technology profiles in one-to-one meetings in order to reach transnational technology transfers.

THEMATIC AREAS

The TTT-day will be focused on technologies and services within the following environmental sectors:

- Measurement of air pollution; Measurement tools, electronic measurement system, analyses/test facilities and methods
- Remote sensing technology; Sensory/multisensor technology, instrumentation
- Environmental and biometric sensors, actuators
- Remote control; Simulation and simulation engineering
- Meteorology (biosensor, moisture sensor, temperature monitoring)
- Reliability and quality (standardisation) of atmospheric emissions and air quality data
- Air pollution and health

PARTICIPANTS

Participation is open to companies, universities and research centres and public administration which offer and/or demand advanced and innovative technologies for controlling and monitoring the air pollution.

METHODOLOGY OF THE TT-DAY

In pre-arranged bilateral meetings, participants will have the opportunity to explore the possibility of future collaborations, such as licensing agreements, development cooperation, joint ventures, commercial agreements with technical assistance or manufacturing agreements. The meetings will be scheduled on the basis of an on-line catalogue, where the registered participants will insert in advance their technology competence profiles and/or their cooperation requirements. The catalogue will be available on the official web site of the event (<http://ecomondo2005.irc.cordis.lu>), where the complete list of participants will be also visible. The deadline to submit technology profiles will be 16 September 2005. Since this date onwards a printed copy of the catalogue will be distributed to the registered participants. An online version of the catalogue will stay open and could be further implemented. Registered participants who on the base of the printed or online catalogue identify interesting contact to meet can request a one-to-one meeting with the proponent. Shortly before the beginning of the fair Ecomondo 2005, participants will receive their individual meeting schedule by email or fax. The bilateral meetings will be held in the IRCs stand (stand 147, Pad. A5) on **28 October 2005** from 9.30 to 17.30.

TECHNOLOGY SHOWCASE

In the occasion of the TTT-day, a scientific committee will select a maximum number of 20 technologies, ready for industrial application, that will have the opportunity to be shown in a Technology Showcase with posters and/or prototypes. The technology showcase will be set up in the IRCs stand (stand 147, Pad. A5) that will be opened to visitor for the entire duration of the fair (26-29/10/2005).
