Objective:

The working group is finalised to design an environmental management systems to allow an organization to manage its main environmental impacts and to achieve targets of sustainable development



Activities:

- 1st phase: Discussion and debate by EEAA and RBOs experts about previously experiences on environmental management systems adopted by organizations in the Egyptian territory (national at local level)
- **2nd phase:** Taking in consideration sustainable development main concepts design an EMS for organization, that includes the following aspects :
- •Choice of an organization according its sector of activities (industrial, agricultural, food industry, cement factory, etc.)
- •An initialenvironmental analysis in which are indicate the main activities of the organization that can produce environmental impacts on the surrounding territory (ex: waste production = possible soil contamination)
- •The environmental policy (EP) of the organization, in which are fixed the environmental objectives of the organizations (ex: 10% reduction air emission), the time to achieve it (ex: by 5 years), which instruments (adoption of new clean technology) and tools of measurement (environmental indicators)



Activities:

- The planning and implementation, to:
- 1. define the main environmental professional figures needed (experts of waste management, environmental regulations experts, etc.) to implement the environmental policy of the organizations
- 2. define the environmental training plan (ex: water management course) to train the employees about the environmental policy adopted by organization
- 3. select what kind of communication tools (web-site, newsletter, annual reports, etc) are needed to inform workers and public about environmental policy of the organization
- 4. a plan for emergency, in which are indicate equipments needed for specific emergency and what kind of organization's activities need a specific monitoring
- The management review, to define possible coorective actions to improve the EMS and frequency of audit activities
- Final presentation and discussion about working group's activities
