1. GENERAL INFORMATION

The project entitled "EU ECO-LABEL CRITERIA revision for COPYING AND GRAPHIC PAPER" was commissioned, in year 2008, by the European Commission to ISPRA (ex APAT - Italian Agency for Environmental Protection and Technical Services), - Service Contract N° 070307/2007/481956/MAR/G2 "EU Eco-label Criteria for Copying and Graphic Paper".
