
#### Aims and Objectives of ERA-ENVHEALTH

An effective coordination mechanism

The ERA-ENVHEALTH project allows the implementation of a network between managers of research programmes. The objectives are to bring together, over the 4 years of the project, the environment and health

research financers and programmers to establish a lasting collaboration between the various organisations by sharing information on research activities and expertise, studying their results and methods, defining priorities for research themes and opportunities for cooperation and organising joint activities and transnational calls for research projects.



Evidence-based policy making

In addition to the need for better coordination across Europe, the World Health Organisation (European region) and the European Commission have expressed the need for better use of Environment and Health (E&H) research results to support policy development, and to better anticipate issues affecting the public. ERA-ENVHEALTH is a contribution to the European E&H Action Plan 2004-2010, promoting the better use of E&H research results to support policy development.
