

PRELIMINARY MARKET CONSULTATION

The maximum value for the supply is € 33.600 (VAT excluded).

The companies are invited to send to ISPRA their best quotes based on the Technical Specifications attached (Annex A) within 15 days from the date of publication on site ISPRA of the present consultation.

In accordance with the Italian Law, in case the Company applies a price improvement, ISPRA reserves the right to exempt the Company from providing a security deposit as a guarantee of the supply.

Requirements and selection criteria are reported below (Art. 4).

ISPRA reserves the right to interrupt, suspend, modify or cancel all or part of the present proceeding without any claim from the Company, which will not be refunded for the submission of quotes or for any preparatory activity.

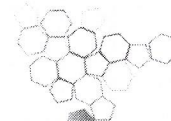
